Matthew Fienup is Executive Director of the Center for Economic Research & Forecasting (CERF) at California Lutheran University and teaches graduate courses in the school's Master of Quantitative Economics Program. Matthew's specialties are applied econometric analysis, the economics of land use, and environmental markets. Matthew is a member of the Wall Street Journal Economic Forecasting Survey. He was the recipient of a 2019 Crystal Ball Award for the Zillow Home Price Expectations Survey (formerly the Case-Schiller Home Price Expectations Survey). CERF's U.S. home price forecast received multiple top-5 rankings among the more than 100 forecasts included in the survey. He is frequently sought to speak on the issues surrounding urban growth restriction and groundwater management policies as well as the general economic outlook for the Nation, the State and the region.
