**THE PACESSETTER:** Lewis Brisbois Bisgaard & Smith is the largest law firm ranked by the number of attorneys in L.A. County with 286 attorneys in its downtown Los Angeles office. That's an increase of nine attorneys from last year. The firm was founded in 1979 by a group of seven attorneys in Los Angeles. It has since grown to more than 1,000 attorneys in 41 offices across 26 states.

**DEAL:** Sheppard Mullin represented Molina Healthcare Inc. in its agreement to acquire Medicare Advantage contracts in 21 states from Aetna Inc. and Humana Inc.

**DOWNTOWN:** Latham & Watkins reported \$2.8 billion in billings for 2016. Its profits-per-partner surpassed \$3 million in 2016, up from \$2.9 million in 2015.

**AVIATION:** O'Melveny & Myers' aviation practice handled the \$4 billion merger of Virgin America and Alaska Airlines and the transfer of Ontario Airport's ownership over the past year.

**AID:** Munger Tolles & Olson name partner Ronald L. Olson was honored for his long history of public service by the Legal Aid Foundation of Los Angeles, which broke ground last year on its new headquarters that will be named the Ron Olson Justice Center.

**MANAGERS:** Reed Smith's downtown Los Angeles and Century City offices appointed new managing partners over the past year.

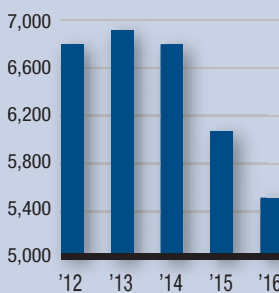

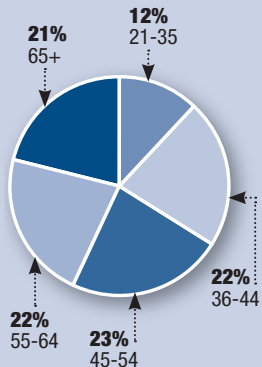
